The City of Las Cruces has pursued the exploration, research, and development needed to establish a Crisis Intervention Team for those persons within the community who are experiencing a mental health crisis. Furthermore, the City of Las Cruces is experiencing an increase in the number of interactions with calls for service from people experiencing a mental health emergency. The mental health emergency strains community and behavioral health-based resources. The likelihood of this situation resolving without innovative intervention is unlikely.

Discussion of grant opportunities under the 2021 Infrastructure Investment and Jobs Act (Bipartisan Infrastructure Legislation - BIL).
